Please leave your room in the condition it was found, or better. Tipping housekeeping staff doesn't hurt - happy housekeeping staff don't complain to management! Trash bags (& litter) will be provided for your convenience. If you have a problem you can't take care of yourself, please let show management know and we will do whatever we can to help. The condition of your room reflects on the entire cat fancy, and it only takes one mishap to lose a hotel (even a whole chain) forever.

## SHOW RULES

TICA show rules will be strictly enforced. Any person entering a cat or kitten in a TICA sponsored show shall agree to abide by and uphold the Rules of this Association. TICA Show Rules, registration information and forms may be requested from TICA, P.O. Box 2684, Harlingen, TX 78551 or 956-428-8046 or downloaded from TICA's website, [http://tica.org/members/publications/shw\\_rules.pdf](http://tica.org/members/publications/shw_rules.pdf).

**Preliminary New Breed, Advanced New Breeds and New Traits:** Per TICA Show Rule 203.19, "ALL Preliminary New Breeds (PNB), Advanced New Breeds (ANB) and New Traits (NT) must have a TICA registration number prior to entry in any TICA show. No Preliminary New Breed, Advanced New Breed or New Trait may enter a show with a "registration pending"."

## HEALTH

This is a non-vetted show. Any cat showing signs of illness, parasites or fungus will be escorted from the show hall, along with any cats owned, housed or augmented by the same exhibitor. All entries should be vaccinated against feline viral rhinotracheitis, calici and distemper (panleukopenia) at least two weeks prior to the show, and should test negative for feline leukemia and FIV ("feline AIDS").

**Any feline from a house or cattery where there has been fungus or any infectious or contagious illness within twenty-one days prior to the opening day of the show is ineligible for entry.** An obviously pregnant or lactating cat will be disqualified. TICA show rules require all claws, front and back, be clipped prior to judging.

## EXHIBITION/FOR SALE

**Exhibition/Sale spaces** are full cage size (45" wide), if space is available. Only exhibitors who have cats competing in this show will be allowed to have Exhibition/Sale cages. Each Exhibition or For Sale cat/kitten **MUST** have an official entry form completed. Per TICA Show Rule 211.9, all cats or kittens, including Exhibition and For Sale must be listed in the catalog. **No kittens/cats may be confined to carriers, either displayed or under bench, during show hours.**

## KITTENS

All kittens entered for competition must be between four (4) and eight (8) calendar months old on the day of the show. No kitten under three (3) months of age will be allowed in the show hall (be prepared to show proof of age). Kittens may be spayed or neutered.

## HOUSEHOLD PETS

We love having Household Pets (HHPs) enter our show. However, they must conform to all the same health standards and age requirements as other entries. Household Pet Kittens (at least 4 months old, but not yet 8 months old) can be either altered (neutered or spayed) or unaltered. All Household Pets 8 months of age and older **MUST** be neutered or spayed. There is no rule against Household Pets being declawed. If you're not sure what color your cat is or in which class it should be entered, refer to the New Exhibitor section above. There's a lot of good information you can access. If you're still not sure, please contact the entry clerk. She may ask for a picture of your cat to help clarify how your cat should be entered.

## LITTER/SUPPLIES

Cat litter will be provided, but please bring your own litter pan, food and water dishes!

## BENCHING

**This is a "Bring Your Own Cage" show.** Each Sturdi or similar type cage will be allotted a 45" space in which to bench. Walmart or Target carry pop up tents if you need one <http://www.walmart.com/ip/SportPet-Pop-Open-Kennel-Medium-CatsDogs-Small-Animals/5192525> Per TICA Show Rule 26.1.2 "No more than two kittens or one cat may be benched in a single cage, whether entered for competition, exhibition or for sale."

## CLERKS AND STEWARDS

Ring Clerks will be paid \$25 per session, plus a fully marked catalog and lunch. Stewards will receive \$10 per ring per session and lunch. Please indicate in the TOES Comments section if you are interested. Do not deduct clerking fees from your entry. Requests for specific judges will be honored to the extent possible. Currently licensed TICA clerks will be given preference.

## AWARDS

Rosettes will be awarded in accordance with TICA show rules. Donations to our rosette fund are greatly appreciated!

## AIRPORT

## BY ENTERING THE SHOW, YOU AGREE TO ALL OF THE ITEMS BELOW.

Show Rule 24.1 Any person entering a cat or kitten in a TICA sponsored show shall agree to abide by and uphold the Rules of this Association.

1. I agree to abide by the rulings of the Show Committee.
2. I am at least 18 years old and am able to enter into a legally binding contract. (If you are not 18 years old or older, or over 18, but are unable to enter into a legally binding contract, a parent or guardian must complete the online entry form.)
3. I understand that submission of an entry or placeholder via TOES constitutes an agreement to pay **IN FULL**, even if I fail to bench.
4. I will send payment via PayPal or mail a check/money order payable to MCCT covering all fees for this show within 24 hours of submitting my entry(ies)/placeholder(s) or by the closing date of the show (whichever comes first) to the designated Entry Clerk. **I agree to pay a \$30 NSF fee to MCCT if my check is returned.**
